

## Plebiscite Checklist

If you plan to open a farm winery or distillery in Nova Scotia and would like to sell your product at the facility location, you will need to ensure the facility is located in a wet area (liquor sales are legal) of Nova Scotia.

If your location is in a dry area (liquor sales are illegal), you will need to conduct a plebiscite. The following are the procedures to follow for a plebiscite.

<ul style="list-style-type: none"> <li>○ Wording of Motion</li> <li>○</li> <li>○ The general wording of the motion the Municipality will need to pass is:   "Resolved that the Council of (insert your municipality and district name here) requests the Nova Scotia Liquor Corporation to conduct a Plebiscite on the question of a (insert the type of facility you wish to build – example farm winery/distillery) outlet for the sale of liquor in the area as provided for in Section 43 of the Liquor Control Act in order that all residents of the area who are eligible to vote are given an opportunity to participate in the decision-making process."</li> <li>○ The municipal solicitor should draft the specific working of the resolution for council.</li> <li>○</li> </ul>	
<ul style="list-style-type: none"> <li>○ Passed Motion</li> </ul> <p>If municipal council passes the motion, they provide a copy of the motion to the NSLC and the Chief Electoral Officer to start the actual plebiscite exercise.</p>	
<ul style="list-style-type: none"> <li>○ Who Votes?</li> </ul> <p>The Chief Electoral Officer will determine the districts to be covered by the plebiscite vote and conduct an enumeration.</p>	
<ul style="list-style-type: none"> <li>○ The Plebiscite</li> </ul> <p>The plebiscite is held on the date designed by the Chief Electoral Officer. If the populace votes in favour, you will be allowed to sell your liquor products at your facility location.</p>	
<ul style="list-style-type: none"> <li>○ Costs &amp; NSLC Contacts</li> </ul> <p>All costs of the plebiscite are borne by the NSLC.
