Re: REVISED: Liquor Sample Importation - Rules and Information

As of October 1, 2013, CFIA (Canadian Food Inspection Agency) requires additional information over and above the CBSA information to import liquor into Canada. Therefore the process for importing liquor samples into Nova Scotia had to be revised to provide the required information. In an effort to assist in bringing in liquor and answer questions around samples, here is some useful information.

Shipping Samples into Nova Scotia

To assist with the importation of samples into Nova Scotia, please ensure the following is completed:

PLEASE DO NOT USE UPS

• Ship samples via courier, DHL Express, FedEx, or Air Canada. Samples must be addressed as follows:

Consignee: SAMPLES – NAME OF CATEGORY CALL*

- Nova Scotia Liquor Corporation
- 93 Chain Lake Drive, Halifax, NS B3S 1A3
- Attention: NSLC Customs

*Example would be, SAMPLES – AUSTRALIA WINE.

If samples are destined for a PWSS Operator, the operator's name must be indicated along with SAMPLES.

• Ensure the NSLC is provided the completed <u>Samples</u> <u>Package Information Form</u> (Appendix A)

• Ensure that a supplier invoice is provided with the samples and the invoice sample prices at wholesale value.

• Mislabeled samples or samples without a supplier invoice will be treated as belonging to the NSLC.

<u>PLEASE NOTE:</u> All sample shipments must include 2 bottles for NSLC evaluation. Exceptions may be made with NSLC approval.

Sample Limits per Article

The maximum number of samples per article that can be brought into Nova Scotia by Registered Representatives/Agents are the following:

- 6 bottles of Wine
- 3 bottles of Spirits
- 18 single units of Beer or RTD
- 3 multi pack selling units of Beer or RTD

Samples for Evaluation

The following number of imported samples can be brought in for NSLC and/or PWSS evaluation at <u>no charge</u>:

- 2 bottles of Wine
- 1 bottle of Spirits
- 6 single units of Beer or RTD
- 2 multi pack selling units of Beer or RTD

Registered Representatives/Agents may include the following with the NSLC and/or PWSS samples for their own evaluation at <u>no charge</u>:

- 1 additional bottle of wine
- 1 additional bottle of spirits
- 2 additional single units of beer or RTD
- 1 additional multi pack selling units of beer or RTD

While Registered Representatives/Agents may arrange for the shipping of samples, PWSS Operators must receive samples for review on their own behalf.

All domestic samples must be received by the NSLC and must be shipped with all excise taxes paid.

Fees charged when samples exceed no charge limits:

- \$10 per bottle of wine
- \$10 per bottle of spirits
- \$10 per 12 single units of beer or RTD
- \$10 for 2 multi pack selling units of beer or RTD

The NSLC will charge liquor representative for **all applicable fees such as courier**, **customs, excise, Provincial tax and bottle deposit.** Please note that all shipments, regardless of import means, will require payment in full prior to their release from the NSLC warehouse.

Required Information/Paperwork for Samples

All samples are to be routed through the Finance Business Unit of the NSLC.

The NSLC requires the following paperwork in order to clear samples with CBSA and CFIA:

- Completed Samples Package Information form (Appendix A)
- Documentation indicating <u>recipient(s)</u> of enclosed samples
- Purchase Order and/or Invoice stating the wholesale value
- Waybill / Manifest

The Samples Package Information form can be accessed on mynslc.com

Clearing Sample Packages

The Sample Package Information form must be completed and forwarded to the NSLC **within 5 days of the sample goods entering Canada**. If the completed form is not provided, the samples will not be authorized to move into Nova Scotia and will be destroyed.

The NSLC requires a **minimum of 5 days** from the day samples arrive at the NSLC warehouse to process the samples.

Communication on Samples

After the samples are cleared and are ready for pickup, representatives will be contacted.

All communications around samples should be via email to <u>customs@mynslc.com</u>, please no phone calls.

Picking up Samples

Samples will only be available for pickup from the mailroom between 1pm and 4pm Monday to Friday.

Also please be advised that we can only hold product in the warehouse for **21 days** after which time the shipment becomes property of the Crown and will be shipped to the Canada Customs warehouse for destruction.
