1270	Departmental Breakage	Product broken by customer or store staff

1300	Over aged	Product that expires before it is sold
1310	In Store Tasting – NSLC	NSLC in store customer tasting
1320	Staff Product Knowledge - NSLC	Tasting by NSLC employees for knowledge
	Manufacturer Breakage	Explanation
1050	Dry Breakage	Broken or damaged bottle found empty in a case.
1060	Particles in Container	Foreign particles found in the bottle, that are not true to the product's character. i.e. cork, flies, glass, insects, wood, etc.
1070	Over aged	Product has passed the best before date (should only be
		used if agreed upon by supplier; otherwise, should be
		departmental expense)
1080	Tampered	Integrity of product has been violated e.g. tamper proof seal
		on case is broken - domestic beer, cap or seal is broken,
		cracked or stripped
1090	Faulty Case/Packing	Packing fault, bottom failure, or closure failure, this relates to
		a manufacturing fault. Also applies to handle failure that is
		non-roller related.
1110	Cracked Bottle	Broken or damaged bottle found after product has been
		transferred from case to shelves.
1120	Missing in Case	Product is missing in a manufacturer's sealed case and
		missing the bottle imprint on the bottom of the case.
1130	Discoloured	Product is not consistent with color compared to other
		bottles. e.g. coolers or wine may become oxidized or
		experience some chemical breakdown, or separation.
1140	Second Fermentation	Product has gone through a second fermentation causing the
	<u> </u>	product to be sparkling, and/or vinegary.
1150	Excessive Sediment	There is excessive sediment or throw in the bottle
1160	Off Scent	Product scent is off from normal such as vinegar, chemical,

1170	Off Taste	Product taste is off from normal such as vinegar, chemical, or
1180	Torn/No Label	taste of an organic nature. Product found in a manufacturer's sealed case with torn or

1240	Handle Failure	Torn handle caused by our roller racks
1250	In Store Tasting – Supplier	Tasting that is held or approved by the supplier
1260	Staff Product Knowledge - Supplier	Supplier performs tasting for the benefit of the NSLC staff
1200	Stall Floudti Kilowiedge - Supplier	Supplier performs casting for the benefit of the NSLC Staff
