



Distillery Requirements

If you are interested in setting up a distillery in Nova Scotia, please use the following checklist as a guideline of the requirements needed.

<p>Written Proposal to the NSLC</p> <p>A written proposal must be submitted for approval by the NSLC. The Proposal should include:</p> <ul style="list-style-type: none"> • Floor plans and site of proposed distillery, including location of manufacturer’s retail store • Structure of Company: Board of Directors, President, etc. • Products to be produced • Method of distribution • Size and type of containers • Production volumes • Quality control (including the type of testing equipment you plan to use, how you plan to test the alcohol strength in your product, what lab you plan to use to test the product for alcohol content and safety, your water source, water test results if using a well, cleaning and sterilization process, cleaning schedule, etc.) • Alcoholic strength • Number of people to be employed • Capital costs, etc. • Written approval from city/town relative to their zoning, etc. • Copy of your federal license from Canada Revenue Agency. • Written approval of your plan from the Alcohol, Gaming, Fuel and Tobacco Division (AGFT) if you already have a liquor license or plan to apply for a liquor license with the AGFT. 	
<p>Canada Revenue Agency Requirements</p> <p>The requirements of the Canada Revenue Agency need to be met, which includes tax requirements and packaging, labeling and quality control of all products. <p>Resource Recovery Fund Board</p> <p>You will need to contact the Resource Recovery Fund Board at 1-877-313-RRFB (7732) or http://novascotia.ca/nse/waste/rrfbns.asp to discuss bottle deposits and labeling.</p>	
<p>Nova Scotia Department of Environment Requirements</p> <p>You will need to contact the Nova Scotia Department of Environment to discuss water regulations. The contacts can be found on their website at: http://www.novascotia.ca/nse/dept/division.compliance.asp</p>	
<p>Municipal Wastewater</p> <p>This type of operation typically generates wastewater that requires pretreatment prior to discharge to sewer systems. Contact your local municipality or wastewater utility early in the planning stages of your operation to determine discharge limits and requirements.</p> <p>In areas serviced by Halifax Water, contact the Pollution Prevention office by email at P2@halifaxwater.ca.</p>	
<p>Manufacturers Permits</p> <p>A Manufacturers Application Form will need to be completed and forwarded to the NSLC. The form can be found on our website at: https://permits.mynslc.com/</p>	
<p>Insurance</p> <p>Send proof of product liability insurance along with your application.</p>	
<p>Hospitality Room Requirements</p> <p>A hospitality room permit may be obtained if tastings are to be offered either at the store or in a separate room located on the premises. If you are planning to have a hospitality room, a Fire Marshall's inspection certificate or letter of approval is required.</p>	
<p>Registered Representative Permit</p> <p>You will also need to register someone, which could be yourself, to act as a representative for the company. Service Nova Scotia and Municipal Relations handle this registration on behalf of the NSLC. You can register a rep by accessing the form at this link - https://accesstobusiness.snsmr.gov.ns.ca/a2b_web/portal/documents.jsf. Under key words type "NSLC" and select your municipality from the drop down list.</p> <p>Make sure you include a letter, on company letterhead, that confirms this person works for the company.</p>

<p>Listing Products with the NSLC</p> <p>Following the establishment of a facility and approval of permit, Application for Listing Forms can be complete and forwarded to the NSLC for consideration (only if you wish any of the distillery products to be sold through the NSLC). Listing is done through Pius Walker at 902-450-5859 or pius.walker@mynslc.com. Approval of the permit does not guarantee automatic listing with the NSLC.</p>	
<p>Audit</p> <p>Manufacturer is subject to audit by the NSLC as required.</p>

<p>Yearly Permit Fees</p> <p>Commercial Distillery Permit (Over 150,000 litres/year production) \$1,000 in the first year and \$2,000 every year after Retail Store - \$200 Hospitality Room - \$100</p> <p>Craft Distillery Class A Permit (under 75,000 litres/per year production) - \$500 Craft Distillery Class B Permit (75,001 – 150,000 litres/year production) - \$500 On-Site Store - \$100.00 Hospitality Room - \$100.00</p> <p>Permits expire annually on March 31 and must be renewed prior to this date.</p>
